1. Call to Order - meeting called to order at 5:43 / Those present: Nancy Comer, Tim Balough, Ellen McMichael, Colleen Goettelman, Caroline Gannon, John Deagan, Andrew Zimmerman, Gail Smith
2. Approval of Agenda - approved
3. Community Comment - none
4. Discussion of funding request from Gail Smith for the 2009 – 2012 5th grade Keystone Science School program - Gail presented an amended proposal for a request for \$1000 in line with our Mission Statement. She offered that the students would put together a presentation for the public after they went to the School.
